<b>Summary Methodology</b> • Analytical Framework, Concepts, Definitions, and Classifications • Scope of the data • Accounting Conventions • Nature of the Basic Data Sources • Compilation Practices	<p>Import price index measures the overall import price movement over a specific time period.</p> <p>Price index (in terms of US dollar) is calculated by the Bureau of Trade and Economic Indices (BTEI), Ministry of Commerce (MOC). Prices are obtained through monthly importer survey, covering over 70 percent of total imports. Weight for index calculation is based on the Customs Department's data. Detail on data collection and index compilation methodology is disseminated on the MOC's website (<a href="http://www.moc.go.th">www.moc.go.th</a>).</p> <p>The BTEI calculates import price index using chained Laspeyres formula. Based on the price index provided by the MOC, the Bank of Thailand (BOT) calculates and disseminates value and quantity indices.</p> <ol style="list-style-type: none"> <li>1. Total import value index is calculated based on total imports (BOP basis).</li> <li>2. Volume index derived from figures in terms of US dollar and baht are equal and are based on the following formula :  <math display="block">\text{volume index} = \text{value index (in terms of US dollar)} / \text{price index (in terms of US dollar)} * 100</math> </li> <li>3. Price index (in terms of baht) = value index (in terms of baht) / volume index * 100</li> </ol> <p>Import indices are classified in accordance with economic classification based on the BOT's list of principal imports specified in the Product Group (PG) classification, which is in line with our import statistics. The figures are seasonally adjusted.</p>
