Definition of terms used in the survey is as follows:</p> <p><b>Employed persons</b> is defined as persons with the age of 15 years and over who during the week in which the survey is conducted, either</p> <ol style="list-style-type: none"> <li>1. worked for at least one hour in exchange for wages/salary, profit, dividend or any other forms of compensation in cash or in kind; or</li> <li>2. do not work at all or work less than one hour but <ol style="list-style-type: none"> <li>2.1 receive wage/salary, profit from business enterprise or farm during the period of absence; or</li> <li>2.2 do not receive wage/salary, profit from business enterprise or farm during the period of absence but would return to work in their permanent job or business.</li> </ol> </li> <li>3. worked for at least one hour without pay in business enterprise or on farm owned or operated by household head or members.</li> </ol> <p><b>Work status</b> are classified as follows</p> <ol style="list-style-type: none"> <li>1. Employers</li> <li>2. Government employees</li> <li>3. Private employees</li> <li>4. Own-account workers</li> <li>5. Unpaid family workers</li> <li>6. Members of producers' cooperatives - classified in accordance with the International Classification of Status in Employment 1993 (ICSE - 93)</li> </ol> <p>The survey is conducted simultaneously for all surveyed units nationwide during the 1<sup>st</sup> - 12<sup>th</sup> of each month. Data are collected by NSO officers through interview with head or member of the household units participated in the survey. Data compilation is based on weighted average of sampled data, the details of which appear in the NSO's website (<a href="http://www.nso.go.th">www.nso.go.th</a>) under the topic "Labour Force Survey".</p>
