The table presents both volume (number of transactions) and value (Billion Baht) of transactions for the respective period.</p> <p>The information shown in the table includes:</p> <ul style="list-style-type: none"> • Number of Working Days (days) refers to the number of the days that the system is operated for services. • Total Cheques Cleared refers to total transactions of cheques cleared. • Average Cheques Cleared refers to average transactions of cheques cleared per day, calculated from total cheque cleared in the specific period <u>divided by</u> the number of working days in that period. • Total Returned Cheques refers to transactions of cheques that are cleared and denied for payment by paying banks. The data was collected since July 2005, based on cheque clearing date. • Returned Cheques with Insufficient Funds refers to transactions of cheques that are cleared and denied for payment by banks with the reasons regarding insufficient funds. • Percentage Change from the same period last year is calculated from the difference between the figure of the particular period and of the same period last year <u>divided by</u> the figure of the same period last year. • The Proportion of Returned Cheques to Cheques Cleared is calculated from total returned cheques <u>divided by</u> total cheques cleared for the particular period. <p>The Imaged Cheque Clearing And Archive System (ICAS) was launched to replace ECS on 3 February 2012. The provincial cheque clearing has been migrated to ICAS since 15 November 2012 and the nationwide implementation was finished in December 2013.</p> <p>The data is derived from the BOT's payment system information system that gathers data from the payment system provided by BOT.</p>
