The transactions are classified by the following ranges of value:</p> <p>The information shown in the table includes:</p> <ul style="list-style-type: none"> <li>• Number of Working Days (days) refers to the number of the days that the system is operated for services.</li> <li>• Total Cheques Cleared refers to total transactions of Intra-provincial Cheque in Regional Areas.</li> <li>• Average Cheques Cleared refers to average transactions of cheques cleared in Intra-provincial Cheque in Regional Areas per day, calculated from total cheques cleared in the specific period <u>divided by</u> the number of working days in that period.</li> <li>• Total Returned Cheques refers to total transactions of cheques that are cleared in Intra-provincial Cheque in Regional Areas and denied for payment by paying banks.</li> <li>• Returned Cheques with Insufficient Funds refers to total transactions of cheques that are cleared in Intra-provincial Cheque in Regional Areas and denied for payment by banks with the reasons regarding insufficient funds.</li> <li>• Percentage Change from the same period last year is calculated from the difference between the figure of the particular period and of the same period last year <u>divided by</u> the figure of the same period last year.</li> <li>• The Proportion of Returned Cheques to Cheques Cleared is calculated from total returned cheques <u>divided by</u> total cheques cleared for the particular period.</li> </ul> <p>Provincial Cheque Clearing has been migrated to the Imaged Cheque Clearing And Archive System (ICAS) since 15 November 2012 and the nationwide implementation was finished in December 2013.</p> <p>The data is derived from the BOT's payment system information system that gathers data from the payment system provided by BOT.</p>
