Regulation of the Bank of Thailand No. Sor.Ror.Khor. 3/ 2565

Re: Procedures for Members of Highly Important Payment System to Enter Business

Rehabilitation or Bankruptcy Proceedings (First Amendment)

#### 1. Rationale

The Bank of Thailand (BOT) ceases to provide the Imaged Cheque Clearing and Archive Systems (ICAS) services and endorses a substitute private ICAS operator. The effort intends to distinguish the roles between the operator and the regulator of the payment systems service providers under the Payment Systems Act. The migration also provides the private sector more convenience to further enhance the systems to interoperate with other related payment services. In this regard, the BOT deems it appropriate to improve the regulation of the Bank of Thailand No. Sor.Ror.Khor. 1/2561 Re: Procedures for Members of Highly Importand Payment System to Enter Business Rehabilitation or Bankruptcy Proceedings, dated 23 April B.E. 2561, by repealing the enforcement of member banks according to the Regulation of the Bank of Thailand Re: The Imaged Cheque Clearing and Archive Systems after the BOT's ICAS services discontinuation.

### 2. Statutory Power

By virtue of the provision of Articles 44 of the Bank of Thailand Act B.E. 2485 and amendments thereafter.

# 3. Amendments

Regulation of the Bank of Thailand No. Sor.Ror.Khor. 1/2561 Re: Procedures for Members of Highly Importand Payment System to Enter Business Rehabilitation or Bankruptcy Proceedings, dated 23 April B.E. 2561

## 4. Scope of Application

This Regulation shall apply to BAHTNET service users according to the Regulation of the Bank of Thailand Re: BAHTNET Services.

#### 5. Contents

5.1 Repeal the Article 3 Scope of Application of the Bank of Thailand Regulation No. Sor.Ror.Khor. 1/2561 Re: Procedures for Members of Highly Important Payment System to Enter Business Rehabilitation or Bankruptcy Proceedings, dated 23 April B.E. 2561, shall be replaced with the followings:

"Section 3. Scope of Application

BAHTNET service users according to the Regulation of the Bank of Thailand Re: BAHTNET Services."

5.2 Repeal the Article 1 of 4 Contents of the Bank of Thailand Regulation No. Sor.Ror.Khor. 1/2561 Re: Procedures for Members of Highly Important Payment System to Enter Business Rehabilitation or Bankruptcy Proceedings, dated 23 April B.E. 2561 shall be replaced with the followings:

"Article 1 in this Regulation

"Highly Important Payment System" mean BAHTNET system.

"BOT" means the Bank of Thailand according to the Bank of Thailand Act.

"Member" means BAHTNET Service user according to the Regulation of the Bank of Thailand Re: BAHTNET Services.

"Transaction" means fund transfer or settlement transaction in BAHTNET."

#### 6. Effective Date

This Regulation shall come into effect from the notification date.
