Notification of the Bank of Thailand

No. FPG. 1/2564

Re: Substitution of financial institutions and special financial institutions' holidays for B.E. 2564 (2021) and additional special holidays

1. Rationale

On 29th December 2020, the Cabinet has announced the deferral of substitution for Chulalongkorn Day and additional public holidays in order to stimulate economy.

The Bank of Thailand has considered and deemed appropriate to revise financial institutions and special financial institutions' holidays for B.E. 2564 (2021), according to the Bank of Thailand Notification No. FPG. 19/2563 Re: Financial Institutions' Holidays for B.E. 2564 (2021) dated 11th September 2020, and the Bank of Thailand Notification No. SVG2. 7/2563 Re: Special Financial Institutions' Holidays for B.E. 2564 (2021) dated 11th September 2020, and to declare the additional special holidays for financial institutions and special financial institutions, to be in accordance with the Cabinet's announcement.

2. Statutory Power

By virtue of the provision of section 37 of Financial Institution Business Act B.E. 2551 (2008) and the amendments thereof, the Bank of Thailand hereby revises financial institutions' holidays for B.E. 2564 (2021) and announces additional special holiday for financial institutions.

By virtue of the provision of section 120/1 of Financial Institution Business Act B.E. 2551 (2008) and the amendments thereof, the Bank of Thailand, as approved by the Minister of Finance, hereby revises special financial institutions' holidays for B.E. 2564 (2021) and announces additional special holiday for special financial institutions.

3. Scope of Application

All financial institutions and special financial institutions under Financial Institution Business Act B.E. 2551 (2008).

4. Holiday Requirement

4.1 The Bank of Thailand announces the cancellation of financial institutions' holidays for B.E. 2564 (2021) on Monday 25th October 2021 (Substitution for Chulalongkorn Day) according to the Bank of Thailand Notification No. FPG. 19/2563 Re:

Financial Institutions' Holidays for B.E. 2564 (2021) dated 11th September 2020, and the Bank of Thailand Notification No. SVG2. 7/2563 Re: Special Financial Institutions' Holidays for B.E. 2564 (2021) dated 11th September 2020 and announces that Friday 22nd October 2021 is substituted holiday for financial institutions and special financial institutions.

4.2 The Bank of Thailand announces additional special holidays for financial institutions and special financial institutions as follows;

1. Friday 12th February 2021
2. Friday 24th September 2021

5. Effective Date

This notification shall come into force as from the day following the date of its publication in the Government Gazette.
