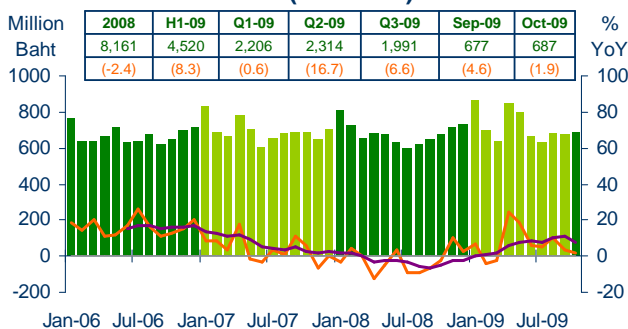

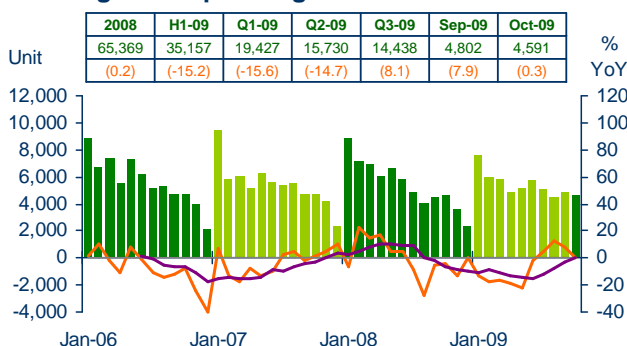

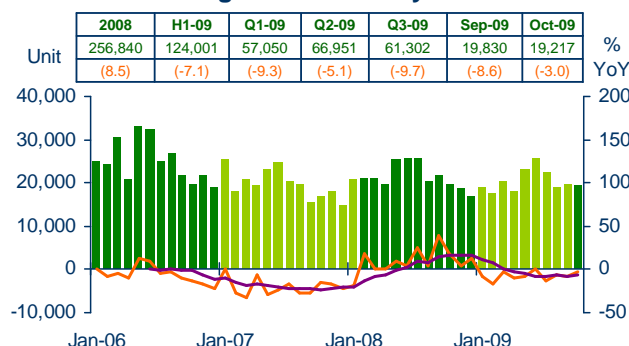
Household electrical consumption

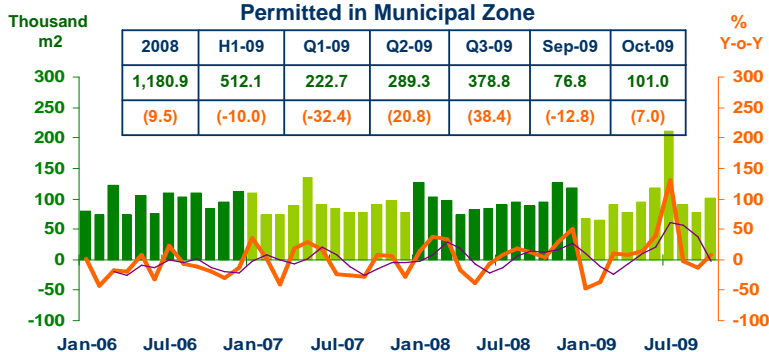

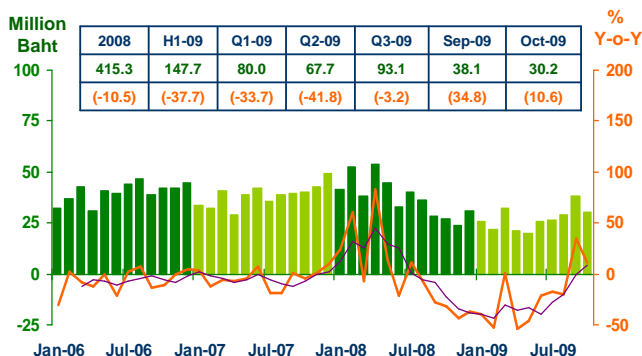

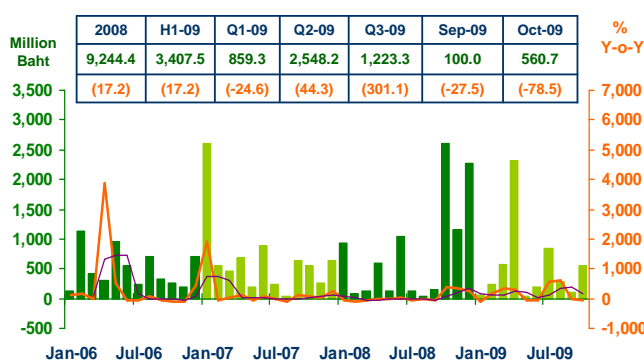
Construction Areas Permitted in Municipal Zone

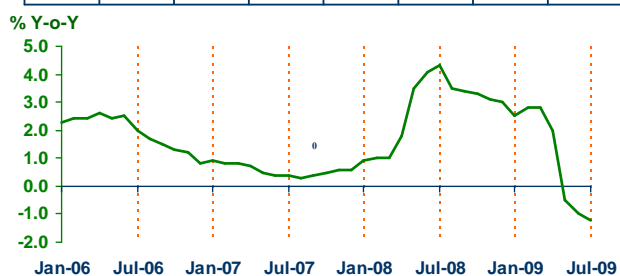
