Re: Financial institutions and specialized financial institutions' holidays for B.E. 2567 (2024)

1. Rationale

To announce financial institutions and specialized financial institutions' holidays for B.E. 2567 (2024)

2. Statutory Power

By virtue of the provision of section 37 of Financial Institution Business Act B.E. 2551 (2008) and the amendments thereof, the Bank of Thailand hereby announces financial institutions' holidays for B.E. 2567 (2024).

By virtue of the provision of section 120/1 of Financial Institution Business Act B.E. 2551 (2008) and the amendments thereof, the Bank of Thailand, as approved by the Minister of Finance, hereby announces special financial institutions' holidays for B.E. 2567 (2024).

3. Scope of Application

All financial institutions and specialized financial institutions under Financial Institution Business Act B.E. 2551 (2008).

For financial institutions and specialized financial institutions branches in Narathiwat, Pattani, Yala, Satun, and Songkhla, extra holidays are given for Eidal – Fitr Day (Ramadan Day), Eidal – Adha Day (Raya Hajji Day) announced by the Sheikhu'l Islam Office, and the Chinese New Year Day if the date does not fall on any of holidays listed above or Saturday and Sunday.

5. Effective Date

This notification shall come into force as from the day following the date of its publication in the Government Gazette.
