Remarks:

1. The Silent Period, or Blackout Period, is a time during which MPC members should refrain from giving interviews or opinions that could influence monetary policy decisions. They should also avoid trading securities or conducting financial transactions that could affect credibility, transparency, and impartiality in their duties. This is based on the Bank of Thailand's regulations on the code of conduct for MPC members (B.E.2553) and the regulations on preventing conflicts of interest for MPC members (B.E.2566).
2. The Silent Period begins 7 days before the first day of MPC meeting. Typically, the first meeting day is held 5 days before the second meeting day, when the MPC decision is announced. Therefore, the Silent Period starts 12 days before the MPC decision date.
