Notification of the Bank of Thailand No. SorRorKhor. 2/2556 Re: Multilateral Fund Transfer Services (Revision 1)

1. Rationale

To accommodate the modification of the delivery of "settlement confirmation advice via the Central Settlement System" for better efficiency, the Bank of Thailand (BOT) has changed the method that requires order transmitter institutions to verify and affirm accuracy of such advice and send it electronically to the BOT, instead of the original method that requires order transmitter institution to print such advice from the Electronic Financial Services (EFS) in order to verify and have it appended with an authorized signatory's signature before sending it to the BOT.

2. Statutory power

To conform to Article 1 (8) of BOT regulation concerning BAHTNET services.

3. Amendment

BOT Notification No. SorRorKhor. 7/2551 Re: Multilateral Fund Transfer Services, dated 12 September 2008

4. Scope of application

This Notification shall apply to BAHTNET users, including order transmitter institutions and transferor/transferee institutions as defined under BOT Notification No. 7/2551 Re: Multilateral Fund Transfer Services, dated 12 September 2008.

5. Contents

1. Repeal the authorization letter for use of Multilateral Fund Transfer services stipulated in Item (1) of the first paragraph of Article 4 of BOT Notification No. 7/2551 Re: ultilateral Fund Transfer Services, dated 12 September 2008, and replace them with the authorization letter form for Multilateral Fund Transfer attached hereto.

2. Repeal the text in Article 8 of BOT Notification No. 7/2551 Re: Multilateral Fund Transfer Services, dated 12 September 2008, and supersede it with following:

"Article 8: Order transmitter institution shall dutifully verify and affirm accuracy of payment settlement transactions via the Central Settlement System (CSS) and submit settlement confirmation advice electronically through the Central Settlement System (CSS) via EFS to the BOT by 10:00 a.m. on the following business day after the Multilateral Fund Transfer order date , unless the BOT stipulates otherwise.

6. Effective date

Effective from 7 May 2013 onwards.
