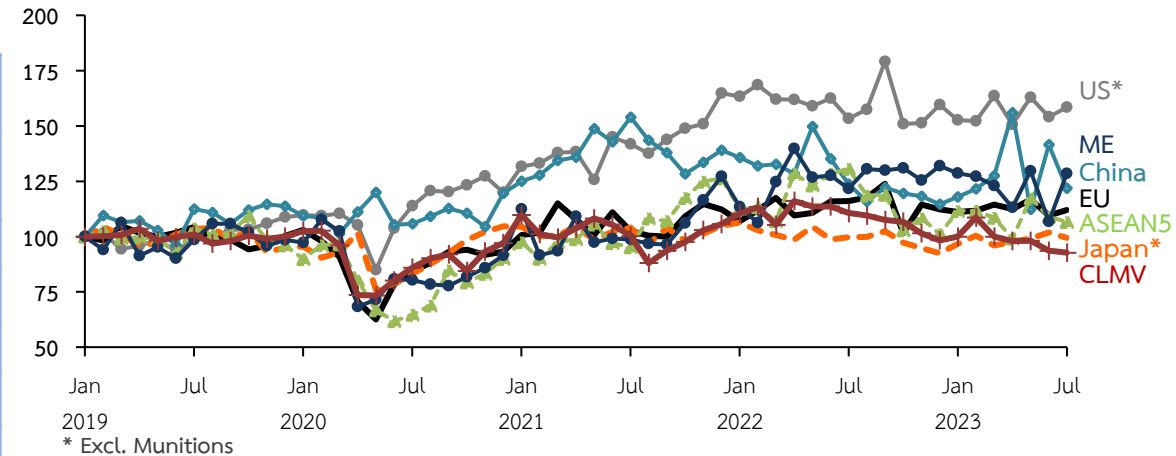

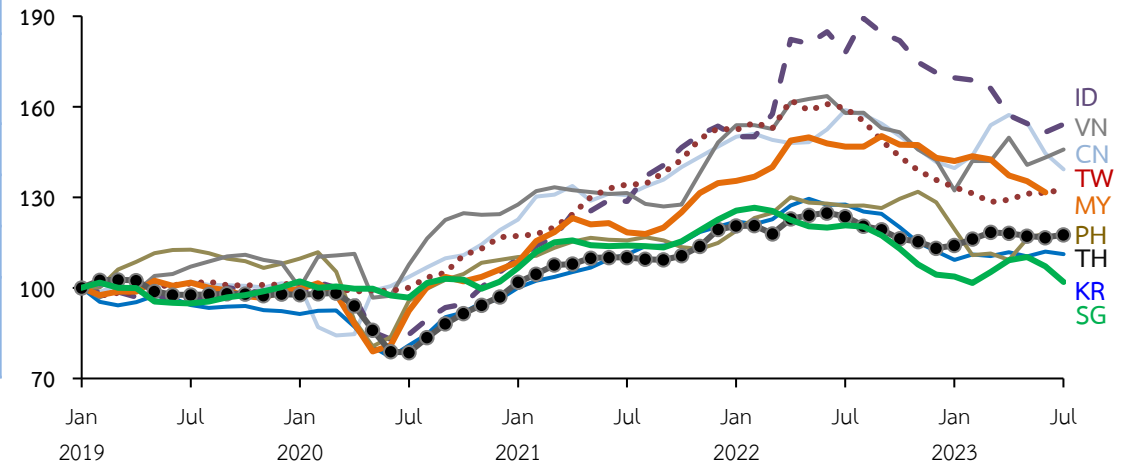
Thai Export to Major Destinations

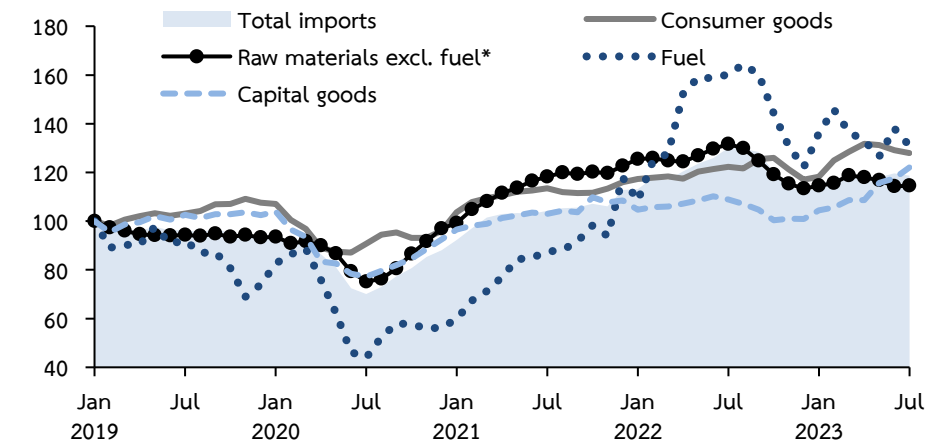

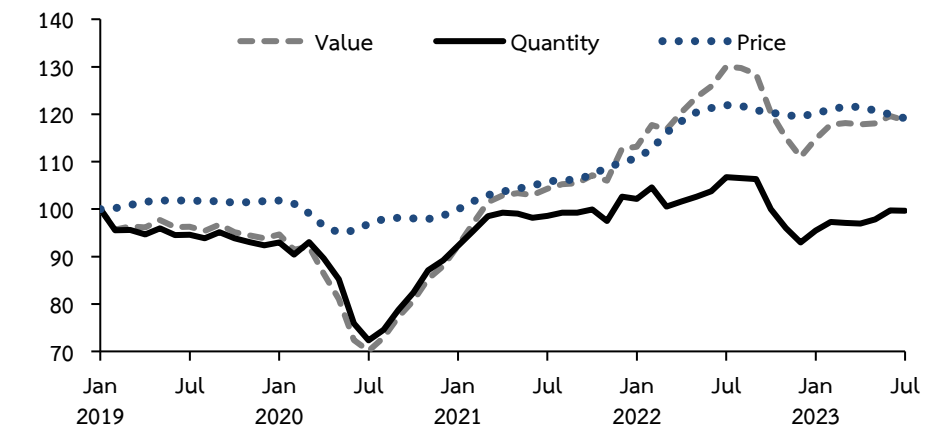

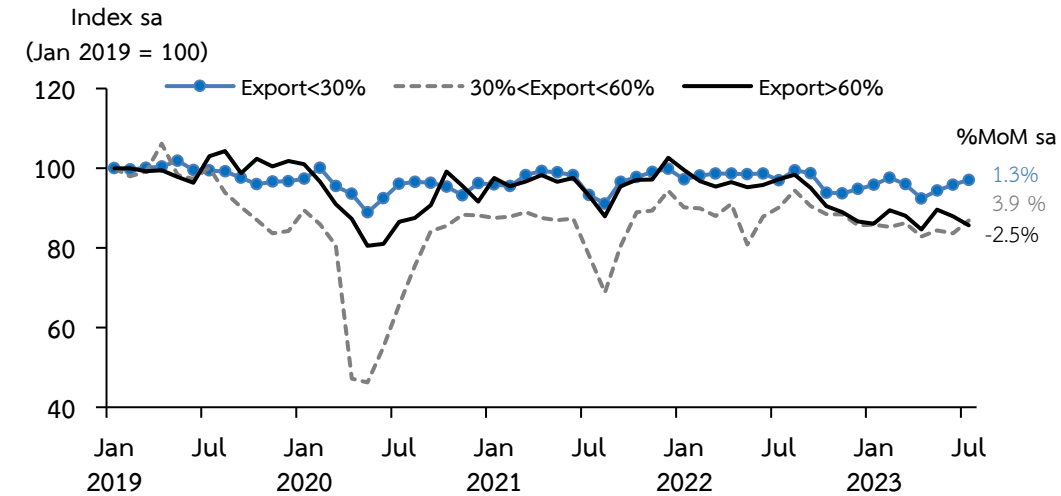

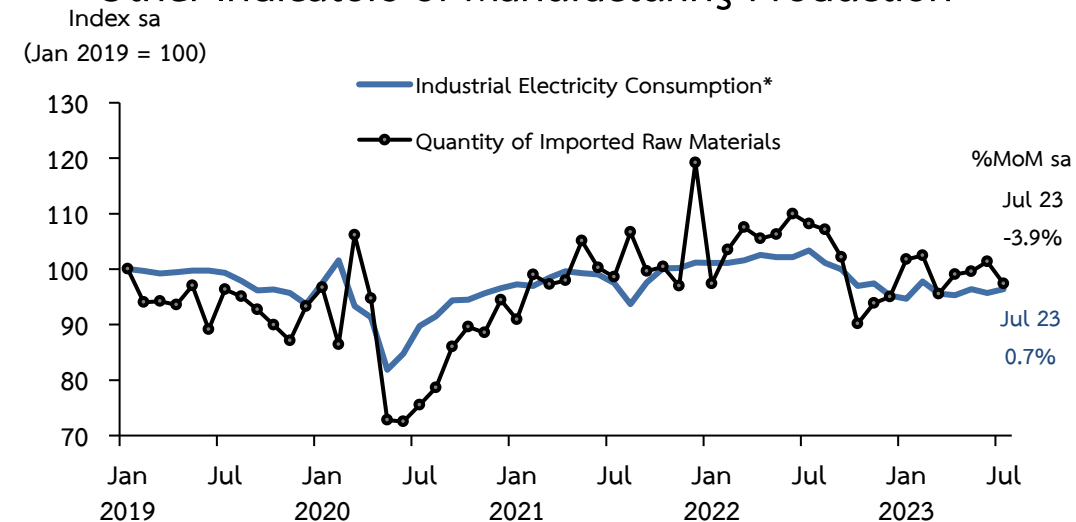

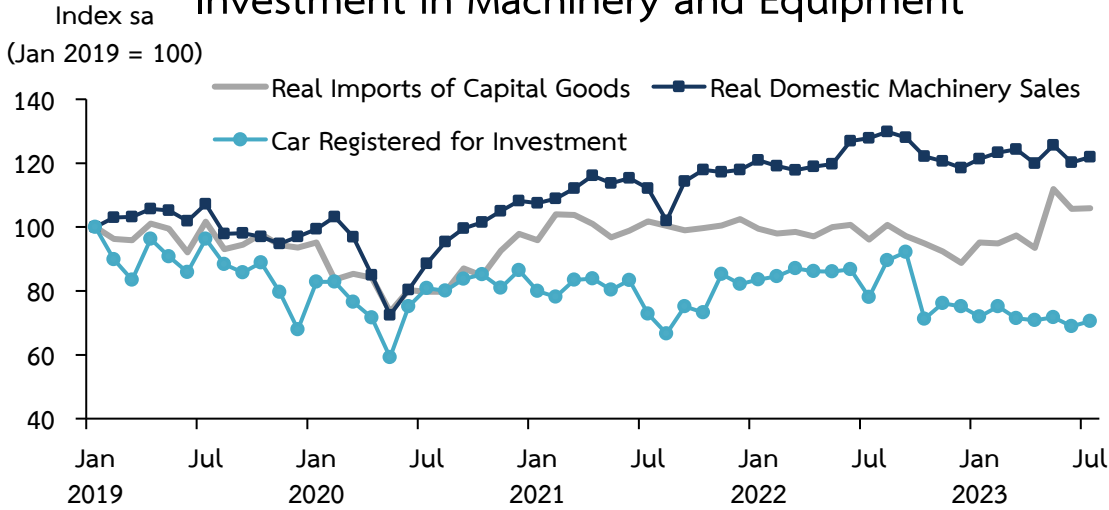

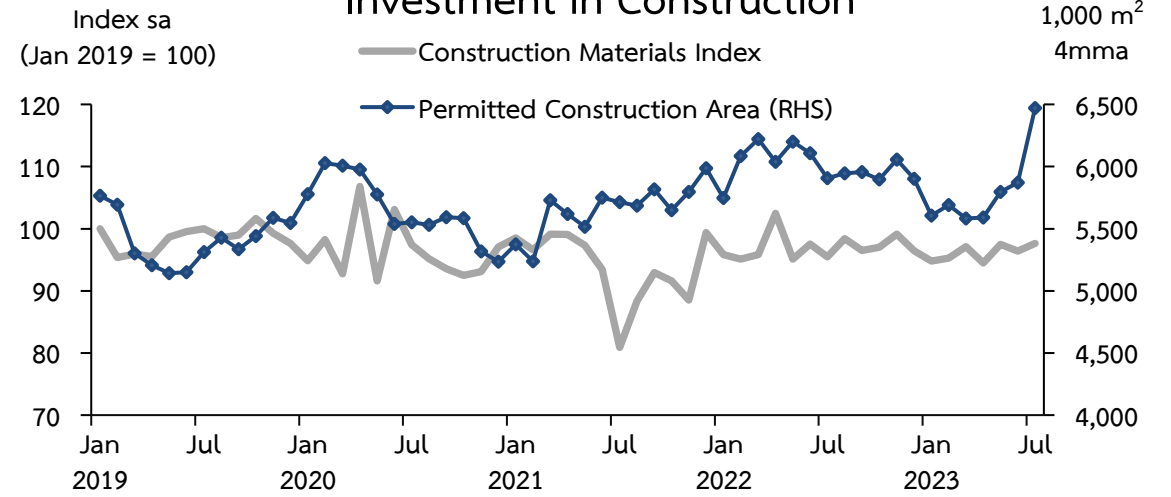

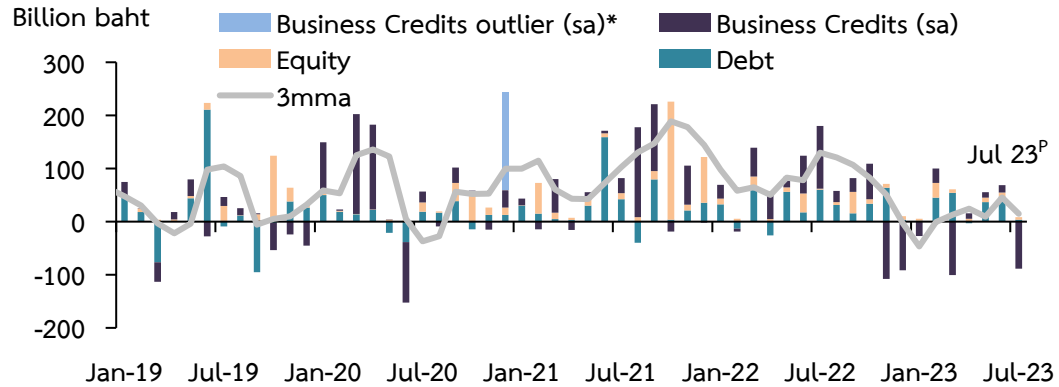
Investment in Machinery and Equipment

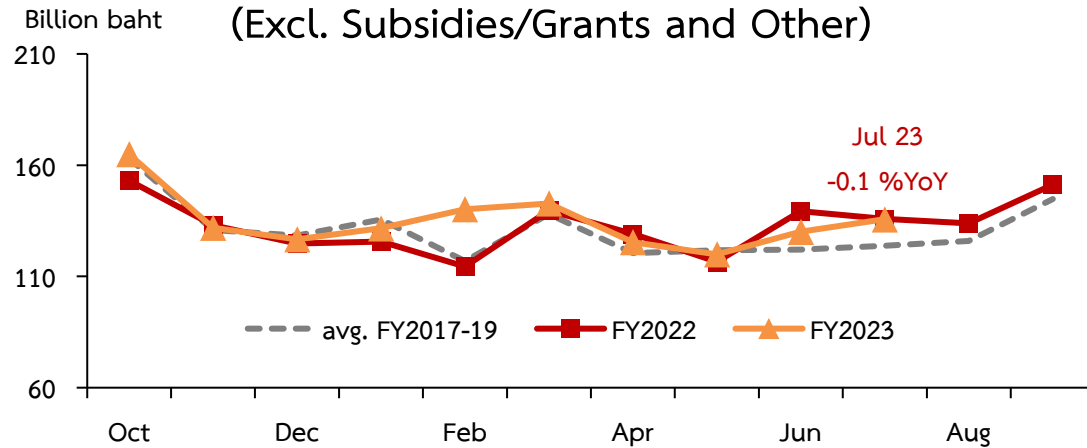

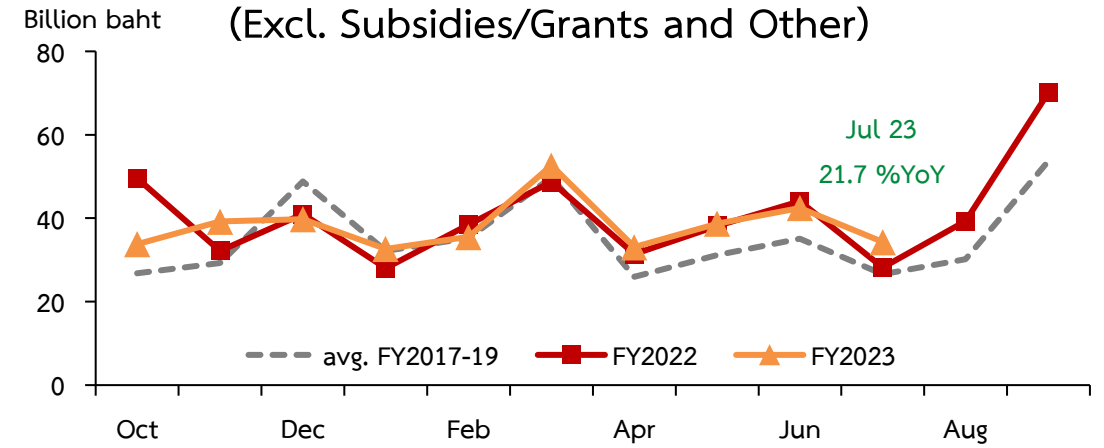
Central Government Current Expenditure

(Excl. Subsidies/Grants and Other)



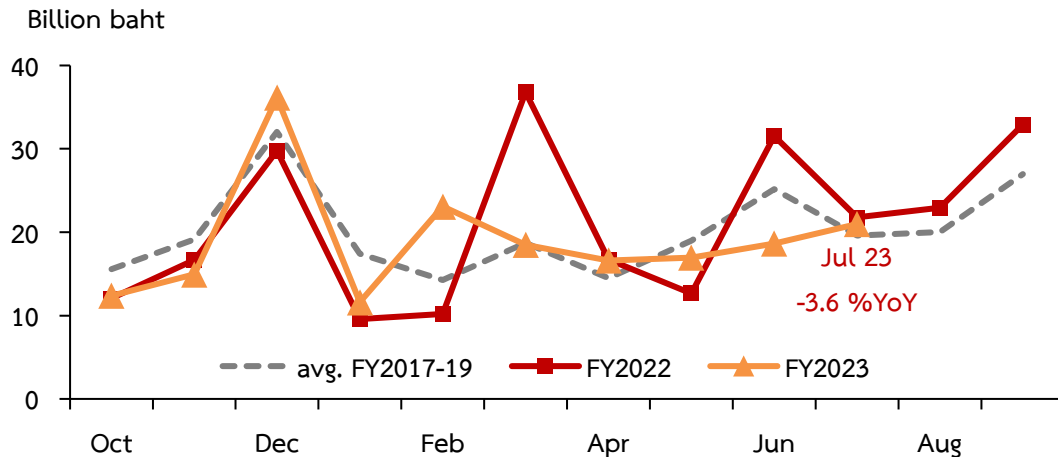
Central Government Capital Expenditure

Fiscal Position (Cash basis)

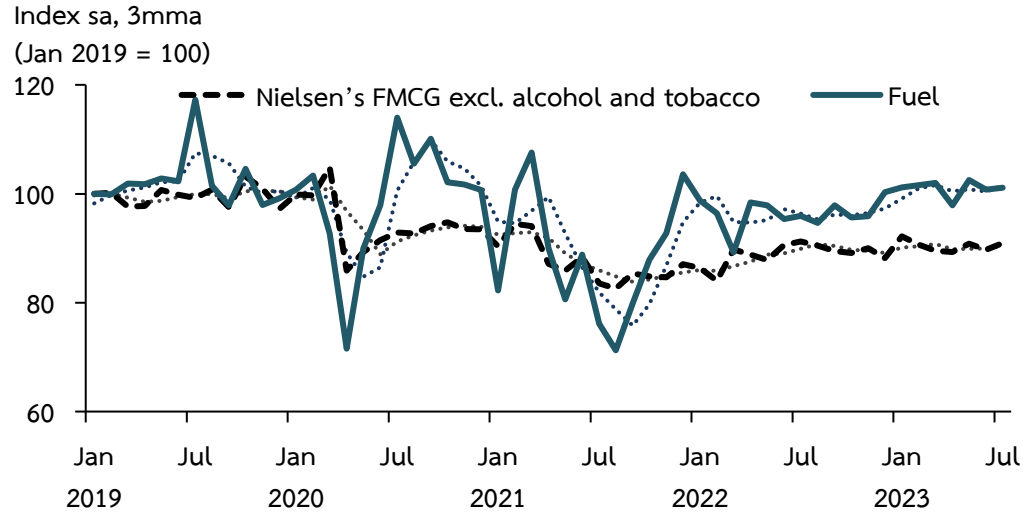

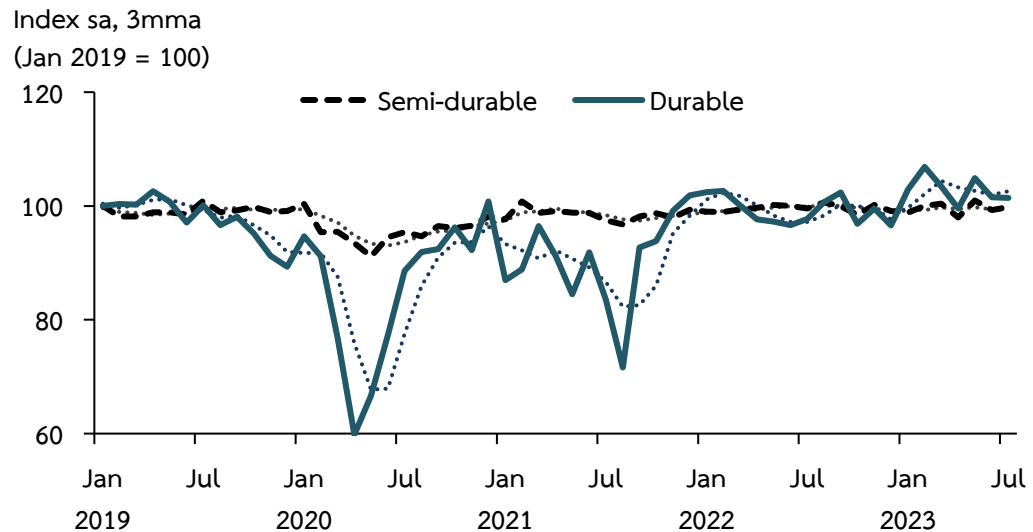


Nielsen's FMCG Index & Fuel Index



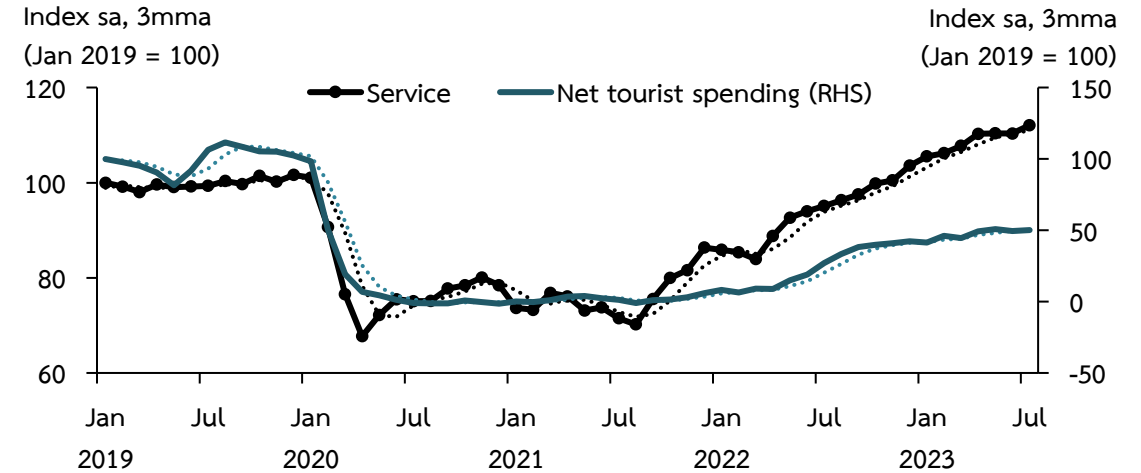

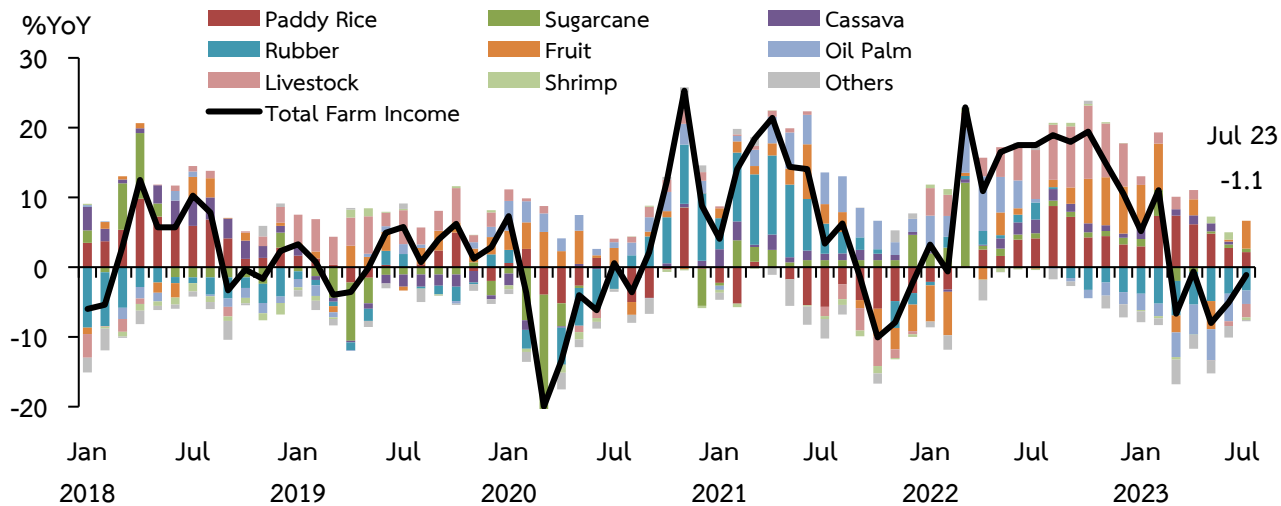

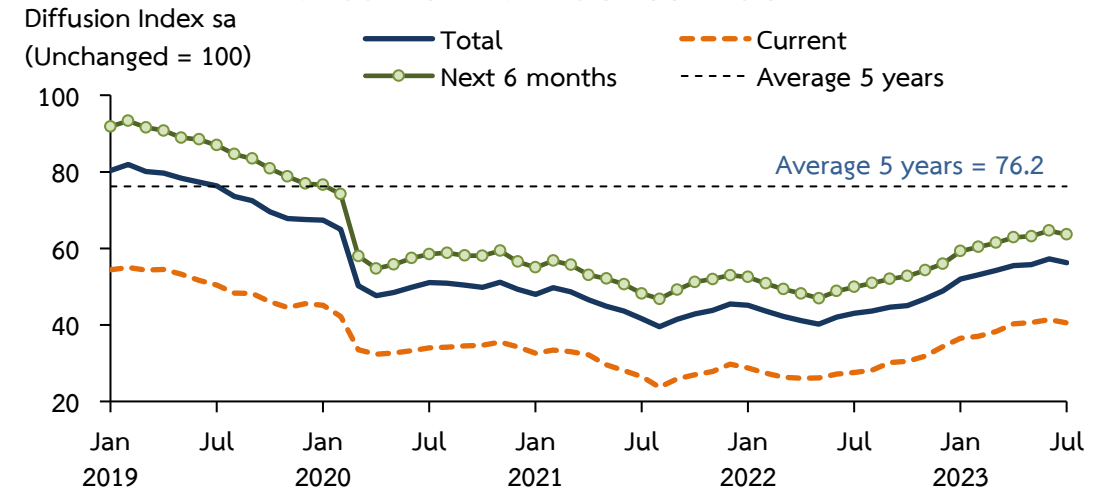

Consumer Confidence Index



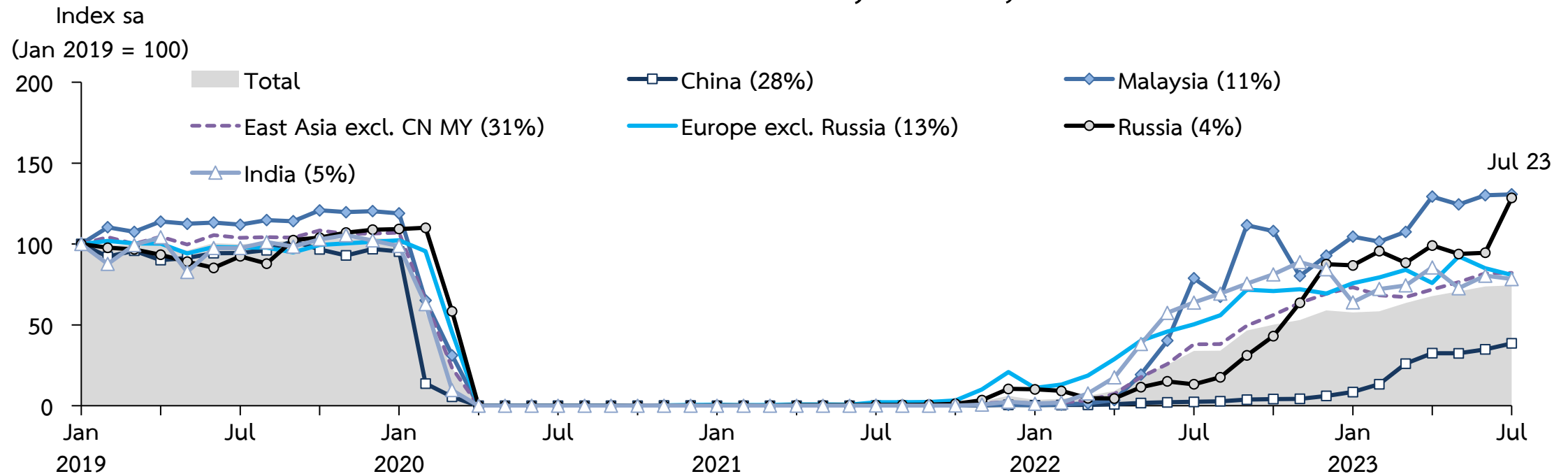

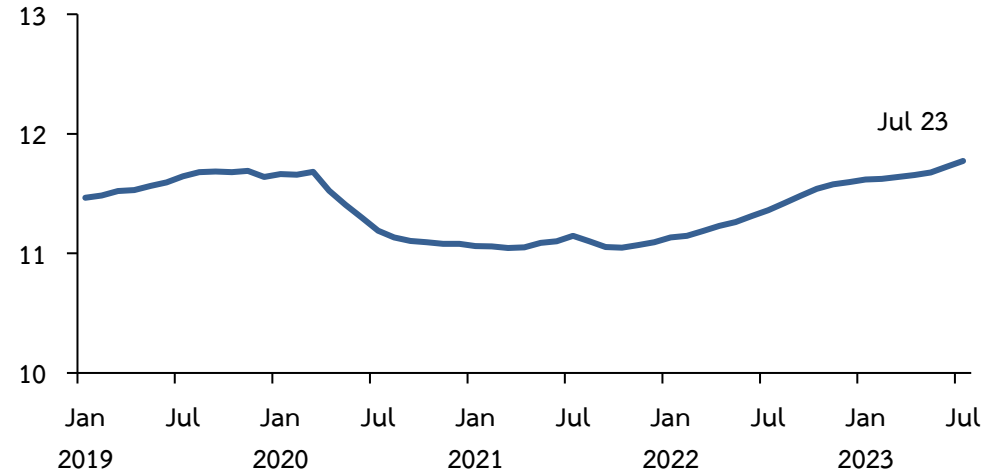
Tourists Classified by Nationality

Total Contributors in Section 33

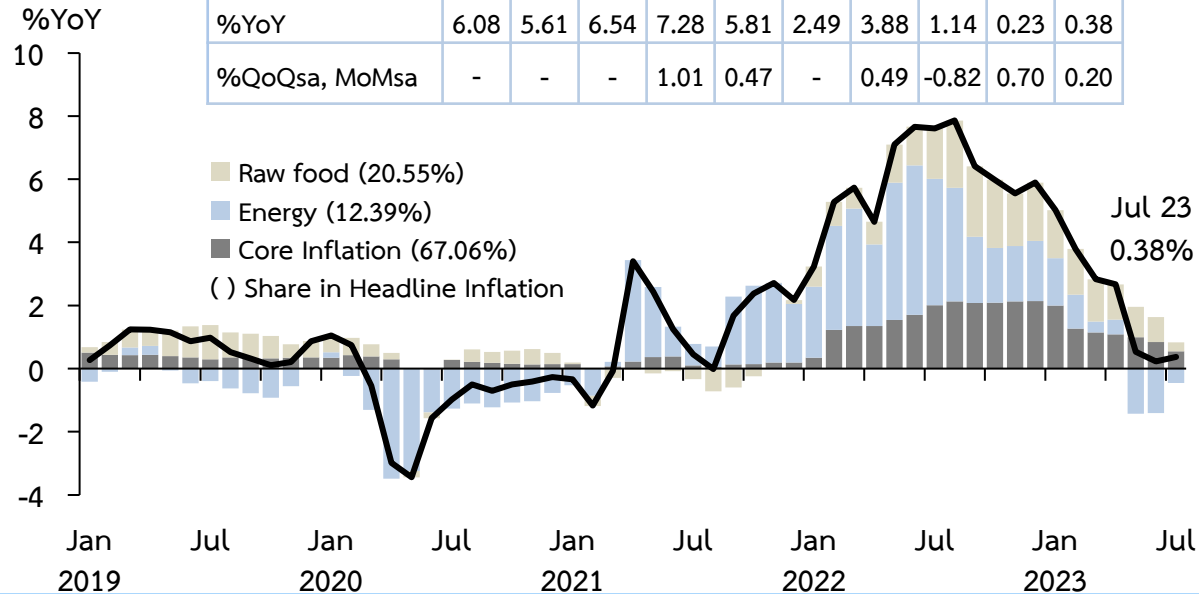

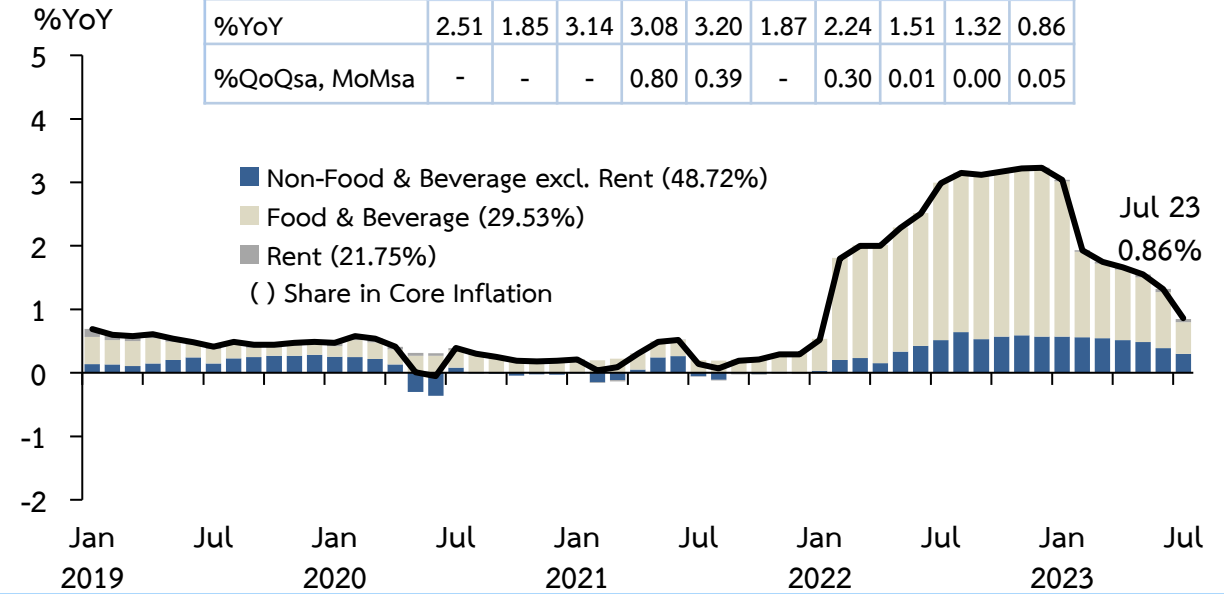

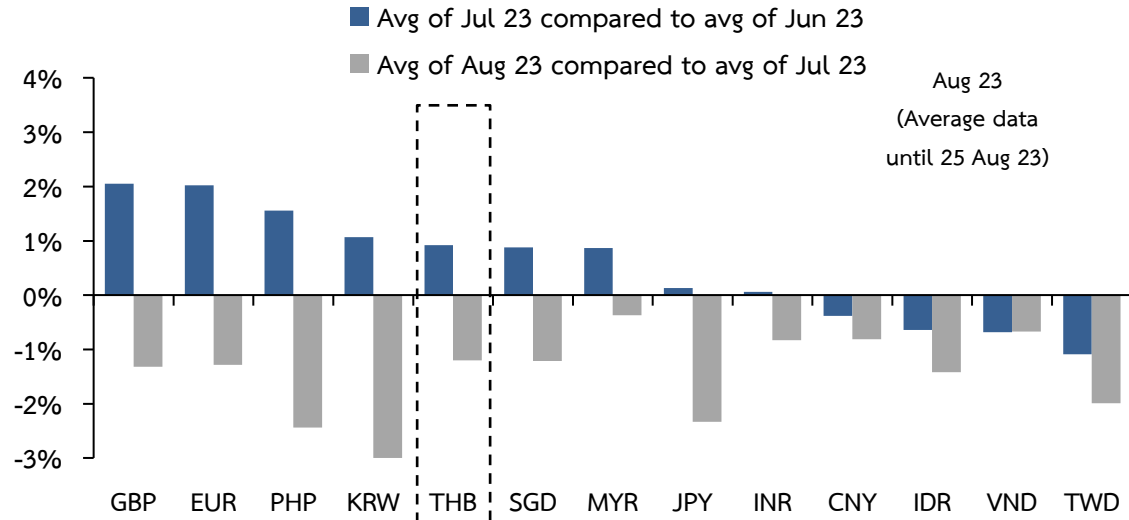

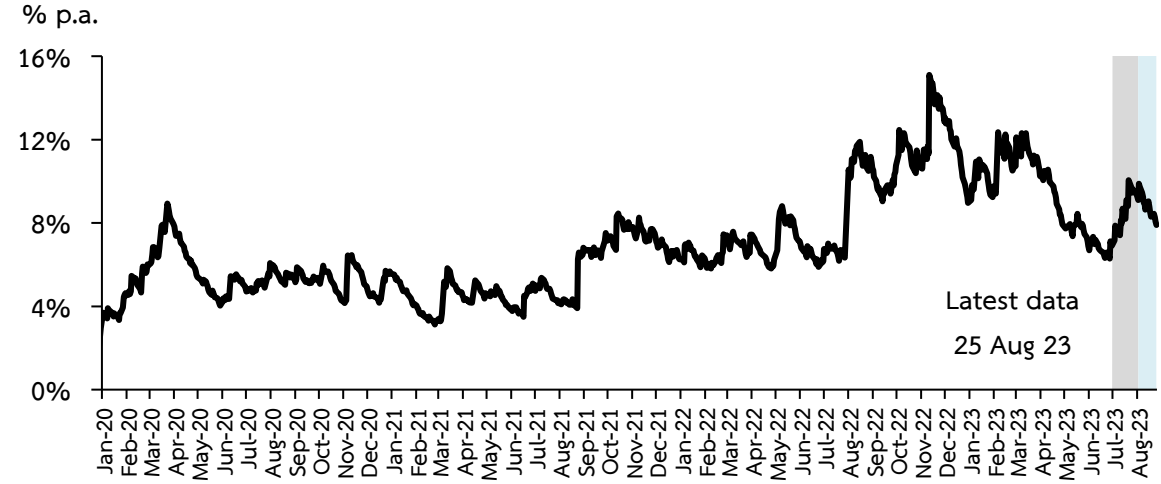


Exchange Rate Movement

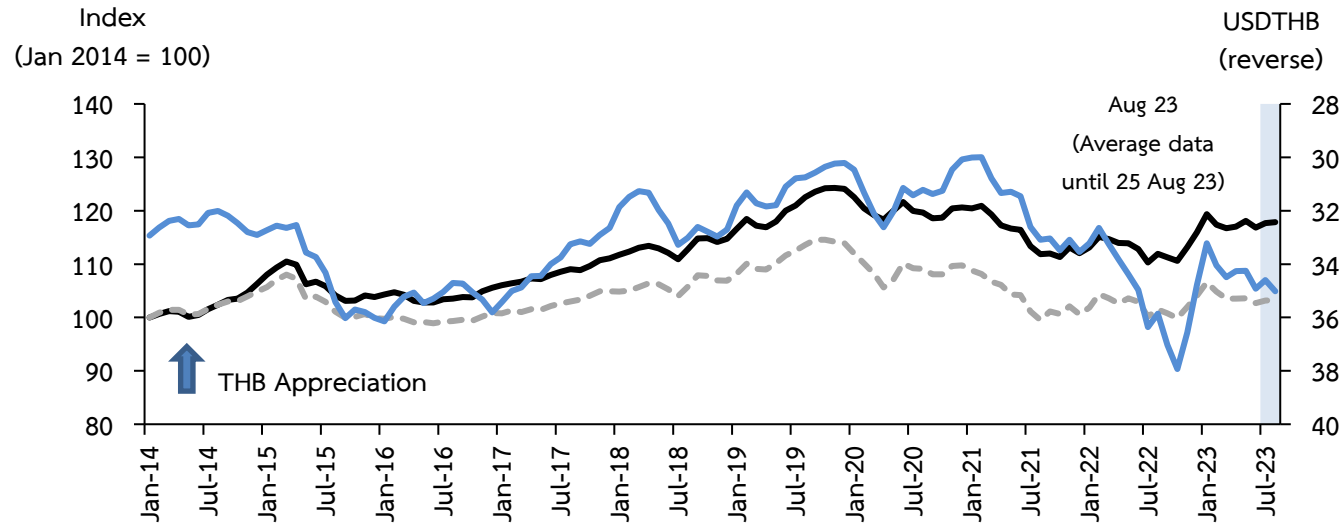

Exchange Rate Volatility (vis-à-vis USD)

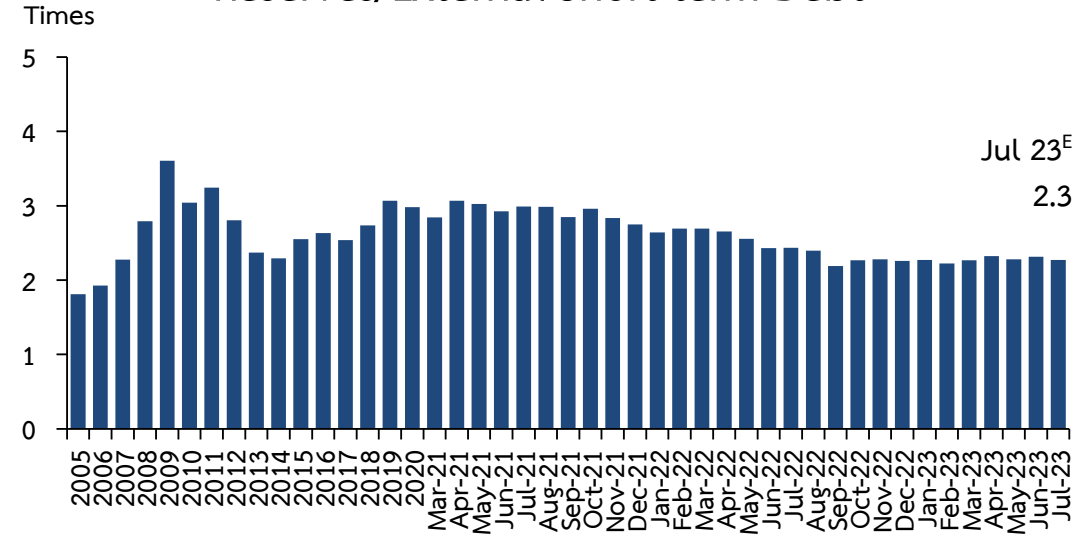
